

JOB DESCRIPTION JUNIOR CONSULTANT IN CLIMATE CHANGE AND ECONOMICS

Le Groupe-conseil Baastel (Baastel) is a consulting firm providing services in the field of international development. Founded in 1989, Baastel's mission is to contribute to sustainable human development. This contribution aims the success and strengthening of development practices and actions (projects, programs, policies) through quality consulting services. Job Description :

Baastel is looking to recruit a Junior Consultant in Development, Climate Change and in particular Climate Change Economics, for a full-time position at its Brussels office. The recruitment will go through a trial period of 6 months whose modalities can be defined by mutual agreement. This person will actively participate in various mandates of the Environment team (and more specifically in climate change, but not exclusively), including the design and preparation of project documents¹, the definition

of baseline and the implementation of monitoring and evaluation frameworks², the conduct of mid-term or final evaluations of projects or programs³, ⁴technical assistance to project implementation, or more specific diagnostics and studies⁵.

On a day-to-day basis, the consultant will conduct data collection through research and document review, interviews with project stakeholders, analysis of quantitative and qualitative data, and writing of reports, publications, etc. The consultant will also be responsible for the development and implementation of the project. He/she will use his/her knowledge of climate change and climate economics and understanding of international development issues to support Baastel in providing quality consulting services. Depending on the needs of the mandates, the consultant will carry out costbenefit and return on investment studies, macroeconomic studies and modeling on the cost of climate change at the regional, national, local or sectoral levels, exercises to cost climate change adaptation options, economic, statistical and financial analyses, and develop value for money methodologies, among others.

He/she will also support the team in the development of technical proposals in response to calls for tenders, at an average of two days per month.

The consultant will join a multidisciplinary team and will have the opportunity to evolve in a dynamic and motivating environment. Once the 6-month trial period has elapsed, and after a period of apprenticeship, the position will eventually require regular travel to countries in the South, particularly in Africa.

Qualifications and skills required :

The desired candidate will have the following qualifications and skills:

Qualifications :

- Master's degree (Bac+5) in economics, development economics, environmental economics or climate change ;
- Two years of relevant professional experience in environmental economics and climate change in an international development context;
